一、招生名額：學士班：94 位；碩士班：10 位。

Admission Quotas : Bachelor's degree programs: 94 students; Master's degree programs: 10 students.

二、修業年限：學士班為 4 至 6 年，碩士班為 1 至 4 年。

Duration of study: 4 to 6 years for a Bachelor's degree program; 1 to 4 years for a Master's degree program.

三、入學時間：秋季班(9 月入學)、春季班(2 月入學)，每學年包含 2 個學期。

An academic year consists of two semesters: The first semester (Fall) begins around in the middle of September ending in the middle of January, and the second semester (Spring) begins around in the middle of February ending in the end of June.

四、本校授課以中文授課為主，申請人應具備基礎之中文聽、說、讀、寫之能力。

All courses are primarily taught in Chinese. Applicants are expected to possess basic proficiency in listening, speaking, reading, and writing in Chinese.

五、春季班入學與同年級一起授課，無另開班。

Students admitted for the spring semester will attend classes together with the same academic cohort; no separate class will be offered.

六、持專科學歷或大學同等學歷申請學士班一年級及轉入二年級、三年級者，本校得視其資格審查，於註冊入學後辦理學分抵免。其學分抵免、提升編級及修業規定，悉依中國科技大學學生抵免學分相關辦法及本校學則辦理。

China University of Technology (CUTe) will examine applications supported by a junior college diploma or academic credentials equivalent to a college diploma, and such applicants may apply for credit transfer after being admitted as freshmen or transfer students. Affairs related to credit transfer, transferring to a higher grade level, and academic studies should be subject to the Regulations for Credit Transfer by Students at China University of Technology and the Academic Rules of China University of Technology.

貳、申請資格 / Eligibility for Application

申請資格係依據教育部《外國學生來臺就學辦法》所規定。辦法如經修正，將以教育部告為準。有關辦法之最新訊息，請洽詢中華民國教育部。

Our admission criteria are based on *MOE Regulations Regarding International Students Undertaking Studies in Taiwan*. If the MOE (Ministry of Education) regulations are updated or changed, current regulations will apply. Please contact the MOE for the latest information.

一、具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者，得申請入學。

Eligible applicants are individuals of foreign nationality who have never held R.O.C. nationality status and do not possess overseas Chinese student status at the time of their application.

二、具外國國籍並符合下列規定，於申請時並已連續居留海外六年以上者

An applicant of foreign nationality who, pursuant to the following requirements, has continuously resided overseas for no less than 6 years is also qualified to apply for admission under this regulation.

(一) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。

Bi-nationals who have R.O.C. nationality status at the time of their application must never have been entered in a Republic of China household register.

(二) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。

An applicant holding foreign nationality, and who once held R.O.C. nationality, but has not been registered as part of a household in Taiwan for at least 8 years, as determined by the Ministry of Interior.

- (三) 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發。
The applicants under the preceding two items have neither previously studied in Taiwan as overseas Chinese students, nor have they been assigned through the Overseas Joint Admissions Committee in the current academic year.

- 三、具外國國籍，兼具香港或澳門永久居留資格，且未曾在臺設有戶籍，申請時於香港、澳門或海外(不含大陸地區)連續居留滿六年以上者。

An applicant holding foreign nationality, concurrently holding a permanent residence status in Hong Kong or Macau, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided in Hong Kong, Macau, or another foreign country (overseas) for no less than 6 years is qualified to apply for admission under these regulations.

- 四、曾為大陸地區人民且具外國國籍，且未曾在臺設有戶籍，申請時已連續居留海外六年以上者。

An applicant who is a former citizen of Mainland China, currently holds a foreign nationality, has never been registered as part of a household in Taiwan and, at the time of application, has continuously resided overseas for no less than 6 years is qualified to apply for admission under these regulations.

- 五、第二、三、四項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間不得逾 120 日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾 120 日予以認定。但符合下列情形之一且具相關證明文件者，不在此限；其在國內停留期間，不併入海外居留期間計算：

The term “overseas” mentioned in section 2, 3, and 4 is limited to countries or regions other than Mainland China, Hong Kong and Macau. The phrase “continuously reside overseas” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. The only exceptions to these stipulations are individuals who (Please note that these exceptions must be supported by written documentation)

- (一) 就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
attended overseas youth training courses organized by the Oversea Chinese Affairs Council or technical training classes accredited by the Ministry of Education (hereafter referred to as the “Ministry”).

- (二) 就讀教育部核准得招收外國學生之各大專校院華語文中心，合計未滿二年。
attended a Mandarin Chinese language center at a university or college in Taiwan for no more than 2 years. Please note: the educational institution must be Ministry accredited.

- (三) 交換學生，其交換期間合計未滿二年。
have studied in Taiwan as exchange students for no more than 2 years.

- (四) 經中央目的事業主管機關許可來臺實習，實習期間合計未滿二年。
worked as an intern for no more than 2 years. Please note: internships must have been authorized by a central government agency.

- 六、外國學生申請來臺就學，依第二至四項，申請入學以一次為限，於完成申請就學學校學程後，除申請碩士班以上學程，得逕本校規定辦理外，如繼續在臺就讀下一學程，其入學方式應與我國內一般學生相同。

In paragraphs 2~4, Upon completion of the courses of study, if an international student intends to apply for another program at the same academic level at a school in Taiwan, the student's admission shall be handled in a manner identical to the procedure of admission for local students. In the case of applications for master's degrees or higher levels of graduate studies can the student's admission be processed under the rules of CUTe.

- 七、符合教育部採認之高中或大專校院畢業者(請參考教育部外國大學參考名冊查詢系統)。申請學士班者須具國外高中畢業學歷、申請碩士班者須具大學畢業學歷。

Applicants who have graduated from a high school, college or university recognized by the Ministry of Education, Republic of China (R.O.C.) can apply for admission (Please refer to the website of the Database for the Reference List of Foreign Universities, Ministry of Education, R.O.C.). Applicants for undergraduate programs must have received high school diplomas. Applicants applying for master's degree programs must have received a bachelor's degree.

- 八、具有與我國學制相當之同等學力資格者。同等學力認定之離校或休學年數計算，自歷年修業證明書或成績單所載最後修滿學期之截止日期，起算至報考當學年度註冊截止日為止。

Applicants whose educational qualifications can be converted into levels equivalent to those within the educational system in Taiwan are eligible to apply for admission. The calculation for the duration of suspension or withdrawal from one's previous studies is determined by two dates; the beginning date starts from the very last day of the final semester as shown on the "Certificate of Study" or the Transcript of Records, and the ending is the enrollment due date of the first academic year with the current program that one is admitted to.

- 九、持相當於中華民國高級中等學校二年級學歷資格報考本校學士班者，應依本校規定補修12學分。

For applicants whose high school graduating level is only equivalent to Taiwan's high school second grade, once admitted, at least 12 credits at CUTe in addition to each department's credit requirements are required before graduation.

- 十、其他申請資格相關規定請詳閱簡章附錄「中國科技大學招收外國學生入學規定」。

For other regulations related to eligibility, please read China University of Technology Regulations Governing Admission of International Students provided in the appendices to this brochure.

註：中華民國國籍法第二條：

有下列各款情形之一者，屬中華民國國籍：

Please note that according to Article 2 of the R.O.C. Nationality Act, a person who fits one of the following descriptions is a national of the Republic of China:

- (一) 出生時父或母為中華民國國民。

A person whose father or mother was, at the time of his (her) birth, a citizen of the Republic of China.

- (二) 出生於父或母死亡後，其父或母死亡時為中華民國國民。

A person born after the death of his (her) father or mother who was, at the time of his (her) death, a citizen of the Republic of China.

- (三) 出生於中華民國領域內，父母均無可考，或均無國籍者。

A person born in the territory of the Republic of China whose parents are both unknown or are stateless.

- (四) 歸化者。A naturalized R.O.C. citizen

(五) 前項第一款及第二款之規定，於本法修正公布時之未成年人，亦適用之。

Clauses 1 and 2 of the preceding Section shall apply to minors on the date of the promulgation of the amendment to this law.

參、報名方式 / How to Apply

一、網路報名 / Online Application : <https://isas.cute.edu.tw>

Please first ensure that you meet the eligibility requirements for application and carefully review the admission guidelines. Prepare all required documents in accordance with the regulations. Applications must be submitted through the International Student Online Application System (<https://isas.cute.edu.tw>). Paper-based submissions will not be accepted.

Photograph in color and less than 6 months old, showing a close-up shot of the head and shoulders, and without wearing a hat. Please upload in JPG format.

(二) 入學申請表(於線上填寫報名)。

Admission Application Form (to be completed through online application submission)

(三) 個人身分證件(身分證或出生證明)及護照影本

Identification document and a copy of passport.

(四) 經我國駐外機構驗證之最高學歷畢業證書影本或同等學力證明文件，如原學歷證件非中文或英文者，請另繳交中或英譯本並加蓋認證章戳。

One photocopy of the certificate or diploma of the highest degree obtained abroad, or documentation of equivalent academic attainment is required. If these documents are in languages other than Chinese or English, a copy of either an English or Chinese translation should also be notarized and enclosed.

(五) 經我國駐外機構驗證之最高學歷歷年成績單，如原成績單非中文或英文者，請另繳交中或英譯本並加蓋認證章戳。

One photocopy of the year-by-year grade transcript issued by the academic institution and verified by a Taiwanese overseas embassy or consulate is required. If these documents are

in languages other than Chinese or English, a copy of either an English or Chinese translation should also be notarized and enclosed.

- (六) 以上「我國駐外機構」泛指我國駐外使領館、代表處、辦事處或其他經外交部授權機構。

“Taiwan’s overseas mission” refers to R.O.C. embassy, consulate, office or other agencies authorized by the Ministry of Foreign Affairs (MOFA), Taiwan, R.O.C.

- (七) 持大陸地區學歷者，依「大陸地區學歷採認辦法」繳交相關證明文件；香港澳門學歷請依「香港澳門學歷檢覈及採認辦法」繳交相關學歷證明文件。

Academic credentials from Mainland China shall be subject to the Regulations Governing the Accreditation of Schools in Mainland China; academic credentials from Hong Kong or Macao shall be subject to the Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao.

- (八) 持馬來西亞學歷者，本校接受經我國駐外機構或馬來西亞留臺校友會聯合總會之認證章戳。

Applicants holding Malaysian academic credentials must have their documents certified with an official stamp from Taiwanese overseas embassy or the Federation of Alumni of Taiwan Universities in Malaysia.

- (九) 應屆畢業之申請生，申請時如尚未取得畢業證書可不必繳交，但註冊時必須繳交。

Recent graduates are not requested to submit the diploma in the application periods. However, the diploma must be submitted when registering at the school.

- (十) 外國學生入學具結書【表 1】

Applicants shall read, fill out, sign up, and hand in.

- (十三) 語言能力規定 / Language Proficiency Requirements

1. 申請就讀時，應提供華語文能力證明。碩士班需提供「華語文能力測驗」(TOCFL)成績B1 級(含)以上能力證明，學士班需提供「華語文能力測驗」(TOCFL)成績A2 級(含)以上能力證明。

Applicants should provide a certificate of language proficiency in Chinese when applying for admission. For Master’s degree programs, a TOCFL (Test of Chinese as a Foreign Language) certificate for B1 level or above is required. For Bachelor’s degree programs, a TOCFL (Test of Chinese as a Foreign Language) certificate for A2 level or above is required.

2. 申請者身份別為以下之一者，無須檢附華語文能力測驗證明但需繳交相關證明。
Applicants who belong to one of the following categories are not required to provide proof of Chinese proficiency test scores but submit relevant documents as proof instead.

- ◆主修華語文或前一學校為中文授課之申請者(例如：馬來西亞華文獨立中學畢業證書)。

Applicants who have majored in Chinese language, or who have studied in a school where Chinese is the medium of instruction (Ex. A diploma or certificate from Malaysian Chinese Independent Secondary School)

(十四) 財力證明 / Financial statement

由金融機構開立 3,500 美元或等同新臺幣 11 萬元之財力證明或獎學金證明。

Proof of USD 3,500 or equivalent to NTD 110,000 issued by a financial institution, or proof of scholarship

肆、甄審方式 / Admission Review Process

一、以書面資料審查為主

Assessment shall be based primarily on submitted documents.

二、招生委員會訂定錄取標準

伍、錄取公告 / Admissions Announcement

一、入學通知書：以書面寄發錄取通知書。

After the admissions posted, CUTe will notify admitted students and issue acceptance letters by both e-mail and post.

二、入學通知書並不保證取得簽證，簽證須由我國外交部領事事務局或駐外館處核給。

The acceptance letter does not guarantee visa issuance. Visas are approved by the Ministry of Foreign Affairs.

陸、報到及註冊入學 / Pre-registration and Enrollment

一、報到 / Pre-registration

- (一) 錄取生應依錄取通知書之規定日期到臺北校區或新竹校區教務處辦理報到逾期未報到，取消入學資格。

Admitted students shall be present at the Office of Academic Affairs, for pre-registration on the designated date specified on the admission letter. Applicants who fail to complete these procedures on time will be regarded as having forfeited their eligibility.

- (二) 經錄取之外國學生註冊入學時，未逾該學年第一學期修業期間三分之一者，於當學期入學；已逾該學年第一學期修業期間三分之一者，於第二學期或下一學年註冊入

學。

An admitted international student who reports registering at our university before it is already one-third of the way into the first semester of the current academic year shall be registered for the first semester. If it is already more than one-third of the way into the first semester, the international student shall register for the second semester or the next academic year.

二、註冊入學相關規定 / Related Regulations of Registration

- (一) 外國學生註冊時，新生應檢附已投保自入境當日起至少 6 個月效期之醫療及傷害保險，在校生應檢附我國全民健康保險等相關保險證明文件。前項保險證明如為國外所核發者，應經駐外館處驗證。

At the time of registration, admitted students should present proof of insurance, including both medical and personal accident coverage for a period of at least six months from the date of their arrival in Taiwan. If insurance is provided by a company in another country, proof of insurance should be verified by a Taiwanese overseas embassy or consulate.

- (二) 依本校學則第 6 條規定，新生因重病、特殊事故或因懷孕、分娩或撫育三歲以下子女不能於該學期入學者，得於註冊截止，檢具相關證明申請保留入學資格經核准後得展緩入學，惟展緩時間以一年為限，毋需繳納任何費用。

According to the Article 6 of CUTE Student Regulations, admitted students who, because of a major accident, serious illness, pregnancy, childbirth, nurturing infants under 3 years old or other causes, are not able to register at the beginning of the semester, can apply to retain their admission eligibility for one year. New students applying for eligibility reservation to the Office of Continuing Education should include their letter of acceptance and written application; no additional fee is required.

- (三) 休學、修業年限、畢業條件及應修學分數、學分抵免等學籍相關規定，請洽臺北校區(電話：+886-2-2931-3416 轉 2191)或新竹校區教務處(電話：+886-3-699-1111 轉 1122)，或至本校網頁查詢，網址：<http://www.cute.edu.tw>。

For matters relating to students' leaves of absence, duration of the term of study, graduation / total credit requirements, and credit waivers, please check with the section of Academic Affairs, Office of Continuing Education Section at Taipei Campus (Tel：+886 - 2 - 2931 - 3416 ext.2191) or Hsinchu Campus (Tel：+886 - 3 - 699 - 1111 ext.1122) or visit our website: <http://www.cute.edu.tw>

- (四) 所繳入學相關證明文件，如有偽造、假借、冒用、塗改等情事，一經查明，取消其錄取資格、不准註冊；註冊入學後發現者，取消入學資格；已入學者開除學籍；畢業者，追繳已發之畢業證書。以上情節皆專案報教育部備查，本校並得送請司法機關追究其法律責任。

Applicants who have used false documents will have their admissions immediately cancelled and will be deprived of their student status as students of China University of Technology. If a violation is discovered after graduation, the degree will be cancelled and any certificates will be destroyed.

柒、申訴程序 / Appeal

申請人對於招生事宜認為有損益其權益情形時，應於錄取公告後一週內提出，以書面具名向本校提出申訴，逾期不受理。【表 4】

If applicants find that the admission results are detrimental to their rights, they may file an appeal with the China University of Technology Admissions Committee by filling out an Appeal Form within one week of the admission results announcement. Appeals submitted after the deadline will not be accepted. 【Form 4】

Due to VISA requirements, students must leave Taiwan within 10 days in the cases of approved leave, drop out or graduation. For students after graduation, one is eligible to apply 6-months residence permit extension and look for jobs. For dismissal situation, students will not be able to apply for any undergraduate (or below) degree in Taiwan as an international student. For reinstatements after approved leave, students need to re-apply and renew residence permit.

The international students who work without a valid work permit will be fined between NTD 30,000 and NTD 150,000. They will immediately be ordered to leave Taiwan and will not be permitted to work in Taiwan in the future. If they fail to depart within the specified period, the Ministry of the Interior National Immigration Agency may enforce their departure or hold them in detention until they are deported. (See Paragraphs 1, 3, and 4 of Article 68 of the Employment Service Act.)
